# Wednesday, November 18, 2015 Singapore

### Thursday, November 19, 2015 At Sea

#### MORNING

**8:00 – 9:00 Welcome: Day 1 -** Your hosts will outline the CME program for the conference along with a turning point technology demonstration day.

### 9:00 – 10:00 Our Corpulent Population - Dr. Robert Dent

During his first session, Dr. Dent will discuss the prevalence of the epidemic in North America, the Commonwealth and other nations. He will also review the costs of the epidemic, the environmental-societal causes and the role of the Physician as a citizen.

### **10:00 – 11:00 TIA –** *Dr. Hyman Rabinovitch*

Dr. Rabinovitch will discuss how to differentiate TIA from other transient entities and which TIA raises concern and needs further urgent investigations. He will also review the appropriate treatment of TIA and the appropriate investigations to detect atrial fibrillation.

#### **AFTERNOON**

#### 3:00 – 4:00 Atrial Fibrillation

This session will be a review of the strategy of rhythm vs. rate control in the era of ablation. There will also be a review of the new oral anticoagulants, considering their differences in choosing an agent for individual patients.

### **4:00 – 5:00** Pulmonary Hypertension – *Dr. Ken Roberts*

Upon completion of this session, participants will have reviewed new classification systems, which redefine one's understanding of primary and secondary pulmonary hypertension on physiologic grounds. Dr. Roberts will pursue specific case examples to introduce aspects of natural history and medical therapies.

# 2:30 – 3:30 A Bridge from Obesity as a Population Issue to Obesity as a

Dr. Dent will discuss the distinction between obesity as a population issue and obesity as a patient issue.

### 3:30 – 4:30 Diffuse Lung Diseases - Dr. Ken Roberts

Dr. Roberts will review specific diseases, such as idiopathic fibrosis and sarcoidosis, with particular attention to clinical and laboratory presentation, natural history, and treatment including recent novel therapies.

### **4:30 –5:30 Acute MI -** *Dr. Hyman Rabinovitch*

During this session, Dr. Rabinovitch will review new data comparing thrombolysis with delayed primary PCI and new anti-platelet agents ticagrelor and cangrelor.

#### 7:30 - 8:30 Stroke

This session will assist delegates in the understanding of the usefulness of emergency interventions and the role of intra-arterial interventions as well as the role of the stroke unit in saving lives.

### 8:30 – 9:30 Hypoventilation Disorders - Dr. Ken Roberts

Dr. Roberts will introduce the broad concepts of type II respiratory failure, commonly defined as chronic hypercapnia, often with normal oxygen gradient. He will also cover the differential diagnosis and diagnostic evaluation, illustrated by specific pathophysiologic examples and introduce specific treatment modalities.

#### **MORNING**

#### 8:00 - 10:00 Global Medicine

This lecture will give a snapshot of the most important public health system issues in Thailand and review current health advice to travelers in Asia. There will also be a discussion on the issues of patients with Obesity and Cardio-Pulminary issues in Asia.

#### **AFTERNOON**

2:15 – 2:30 Welcome: Day 5 - Your hosts will outline the CME program for the morning.

### 2:30 - 3:30 Lipids 2015

This session will be a review of new data regarding niacin, CTEP inhibitors and PCS K9 inhibitors.

### 3:30 – 4:30 Obesity Types - Dr. Robert Dent

Dr. Dent will review the phenotypic types and the genotypic types during this lecture

### **4:30 –5:30 Migraine -** *Dr. Hyman Rabinovitch*

During this session, Dr. Rabinovitch will review the concerns about diagnosing migraines and the predispositions to chronic migraine and its prevention. He will also discuss the role of natural as well as pharmacologic approaches to migraines.

### 7:30 – 8:30 Sleep Disordered Breathing - Dr. Ken Roberts

In this session, Dr. Roberts will review basic concepts and definitions, with attention to epidemiology of this rapidly evolving branch of respiratory medicine. Specific topics will include clinical and laboratory assessment, the relationship of sleep apnea to systemic disorders including cardiovascular morbidity, and current management strategies.

# 8:30 – 9:30 Parkinson's Disease - Dr. Hyman Rabinovitch

Dr. Rabinovitch will discuss the components of Parkinson's Disease and help delegates to a more rapid and accurate diagnosis. He will also review why there is a high false diagnosis rate amongst experts and how to start therapy and how it changes with the disease progression.

### 9:30 – 10:30 Setting the Stage for Treatment: Dealing with Barriers

Dr. Robert Dent

During this session, Dr. Dent will review the barriers to treatment of Obesity.

### 3:00 - 4:00 Heart Failure

This session will review the pathophysiology and treatment options in heart failure with preserved ejection fraction (HFPEF).

#### **4:00 – 5:00 Venous Thromboembolism -** *Dr. Ken Roberts*

At the end of this session, delegates will appreciate the variety of clincial presentations including risk factors, and the multisystem consequences of venous thromboembolism. Dr. Roberts will review various diagnostic algorithms. Coverage of medical treatment will include attention to acute and extended time frames, as well as secondary and primary prophylaxis, with an update on the role of specific targeted anticoagulants.

Dr. Rabinovitch will discuss the neurological diagnoses that masquerade as depression and the diagnosis of fronto-temporal dementia along with the diagnosis of rapid onset dementia.

Dr. Dent will emphasize the importance of long-term intervention for this chronic medical condition and provide the evidence for and expectations from the three long term interventions.

9:30 - 10:30 COPD - Dr. Ken Roberts

During this session, delegates will discuss prevalence, casual factors and pathophysiology. Clinical and laboratory assessment will be covered, with particular commentary on pulmonary function and radiologic assessment. Discussion of management will include attention to treatment of exacerbations, management of the stable patients, and aspects of critical and terminal use.

Dr. Rabinovitch will review the new classification of MS and how to make the diagnosis of MS. He will also discuss the multiple medications and other interventions to modify the course of MS and how to monitor these medications and interventions.

This session will focus on specific clinical vignettes, covering presenting features, diagnostic path, and treatment interventions. Dr. Roberts will review rare presentations of common diseases along with unusual complications that may arrise, and common presentaitons of rare diseases.
